1. Summary of our assessment

We have assessed that:

- Our **5-Year Fixed Heartland Remortgage 80% LTV (R306)** product continues to meet the needs, characteristics, and objectives of customers in the identified target market.
- The intended distribution strategy remains appropriate for the target market.
- The Product provides fair value to customers in the target market (i.e. the total benefits are proportionate to total costs).

2. Product characteristics & benefits

The products are designed to meet the needs of the target group, this being people looking to remortgage their existing property. The product features and criteria are designed to support these needs.

- A fixed scheme for an initial period of 5 years, after which the Societies will apply.
- This product allows purchases up to 80% LTV.
- Available for remortgages only.
- Overpayments (monthly or lump sum) up to a total of 10% of the outstanding loan per year are allowed without charge.
- This mortgage is portable, subject to suitable security and underwriting assessment.
- An early repayment charge will be payable if the mortgage is redeemed within the first five years.

3. Target market assessment and distribution strategy

This target market assessment matrix segments the target customers for the Product, recognising their different needs to enable you to tailor the services you provide when you distribute the Product.

The Product is not designed for customers who:

- Are purchasing their main residence.
- Are remortgaging a property that is let to tenants or on a short term let basis.
- Are borrowing more than £750,000.
- Are borrowing less than £30,000.
- Meet the FCA's definition of 'credit impaired'.
- Do not meet our lending or property criteria.
- Require a mortgage with no early repayment charges.
- Require a discounted rate mortgage.
- Require the ability to make unlimited overpayments.

4. Customers with characteristics of vulnerability

The Product is designed for the market segment defined above, which is likely to include some customers with characteristics of vulnerability or who will experience vulnerability over time.

We considered the needs, characteristics, and objectives of customers with characteristics of vulnerability at all stages of the design process for this Product to ensure the Product meets their needs.

We have not identified any particular areas of vulnerability within the market segments the product has been designed to serve, but have considered whether the pricing structure and design would mean that any customer with aspects of vulnerability are less likely to receive fair value.

We have also tested the Product to assess whether it will meet the identified needs, characteristics, and objectives of the target market, including customers in the target market who have characteristics of vulnerability.

We have in place a framework to achieve good outcomes for vulnerable customers, which includes:

- Education and training for our staff to ensure they have the appropriate skills and experience to recognise and respond to the needs of vulnerable customers.
- Suitable customer service provision and communications.
- Flexible policies, where appropriate, to support vulnerable members
- Monitoring to ensure we continue to meet and respond to the needs of customers with characteristics of vulnerability.
